Perkins V

H.R. 2353, the Strengthening Career and Technical Education for the 21st Century Act, known in short as "Perkins V," has now reauthorized as of July 31, 2018. A transition plan for this funding will be due to the Federal Government by April 2019 and a 4-year statewide plan will be due by April 2020. If the interim plan requirements are the same as in past reauthorizations it will minimally require additional narrative within the Title I-C interim District application detailing how the District will use the interim year to become ready to implement Perkins V.

Perkins IV Title I-C Allocations 2018-19

As specified in the June update and the original allocation memo sent to the Districts, we expect to get final allocations for Title I-C basic grant funding by October 2018 and will give instructions for amending amounts as soon as the final allocations are determined. We do expect that if the allocations change they will go down not up.

2018-19 Perkins Master Calendar Dates

October 1, 2018 -- District 2017-18 Financial Aid data due to the Chancellor's Office.

December 1, 2018 -- This is the deadline for resubmission of 2017-18 Financial Aid data for use in the SFA reconciliation for 2017-18 BFAP-SFAA administrative funding.

Quarterly Reporting – Every quarter districts are required to report and certify their Perkins <u>Title I-C</u>, <u>CTE Transitions</u>, and <u>Title I-B</u> expenditures in the Year-To-Date Expenditures and Progress Report online system. The reporting schedule ensures that districts are reimbursed in a timely manner. The following reporting dates will apply for FY 2018-19.

Strong Workforce Program

NOVA Strong Workforce Program Fiscal Reporting Deadlines -- Strong Workforce Program fiscal expenditure reporting for 2017-18 will be due by September 30, 2018. This reporting will consist of an annual report for each project, which will summarize each -to-date, from project start through June 30, 2018. The NOVA module for fiscal expenditure reporting will be open for reporting beginning August 1, 2018. Beginning in program year 2018-19, each Strong Workforce Program project will report on project expenditures-to-date on a quarterly basis, due 45 days after the end of each fiscal quarter. Below is a summary of due dates for 2017-18 and 2018-19:

- September 30, 2018 2017-18 Annual fiscal expenditure report
- November 15, 2018 2018-19 Quarter 1 fiscal expenditure report
- February 15, 2019 2018-19 Quarter 2 fiscal expenditure report
- May 15, 2019 2018-19 Quarter 3 fiscal expenditure report
- September 30, 2019 2018-19 Annual fiscal expenditure report
